- 1. CALL TO ORDER: January 9, 2021 at 13:02 Pacific
- 2. <u>APPROVAL OF MINUTES:</u> Minutes of the November 14, 2020 PNR Board of Directors meeting were approved as distributed:
 - 1. Motion to approve the minutes was made by Russ Segner and seconded by Rich Pitter.

3. **OPENING COMMENTS:**

- 1. Brief discussion about campaigning in newsletters and other NMRA publications, discussion of deadlines for nominations and bio in newsletters. Most important aspect was equal placement.
- 2. VP report: Roster list has been received, with expirations, 30 and 60 days overdue lists. A survey of members leaving found that the primary reasons included Change in Interest, Age, Downsizing. There were no problems in regards to management. Essentially we're sound
